



ATTENDING ST. ANDREW PRESCHOOL DURING COVID-19

To minimize the risk of transmission of COVID-19 and take full precautions to keep all students and staff healthy, **we ask you to review all of the information contained in this document and the 2020 – 2021 Family Handbook.**

Until further notice, we are asking all families to wear a mask at arrival and dismissal and practice 6-foot physical distancing. Staff and children will have their temperature taken upon arrival and complete a brief health screener (see below). Any staff or child with a temperature of 100.4 F will not be allowed to attend.

Health Screening Questions

1. Have you or your child had a fever of 100.4 F or higher within the past 72 hours?
2. Have you or your child displayed any potential symptoms of COVID-19, such as shortness of breath, new loss of taste or smell, or sore throat within the past 72 hours?
3. Have you or your child had direct contact with a person who had potential symptoms of COVID-19 or who may have been exposed to COVID-19?
4. Has your child taken any fever reducing medications, such as acetaminophen or ibuprofen, in the past 24 hours?
5. To the best of your knowledge, is your child free of symptoms of other communicable illness and healthy enough to engage in daily activities, including outdoor play?

Confirming you've read this and the information contained in the 2020 – 2021 Family Handbook represents your full understanding of the risks and benefits of attending preschool during the COVID-19 pandemic. As a result of COVID-19 being declared a worldwide pandemic by the World Health Organization, federal, state, and local governments recommend social distancing and other health measures. St. Andrew Preschool is doing everything we can to be compliant with all regulations and ensure your safety. We have put in place preventative measures to reduce the spread of COVID-19, but cannot guarantee that you or your family members will not become infected with COVID-19.

By participating in programs, services, and activities at St. Andrew Preschool, you agree to the following:

On behalf of yourself and your child(ren), you hereby release, covenant not to sue, discharge, and hold harmless St Andrew Preschool and St Andrew Lutheran Church, its employees, agents, and representatives, of and from all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating to your participation in our programs, services, or activities. You understand and agree that this release includes any claims based on the actions, omission, or

negligence of this organization, its employees, agents, and representative, whether a COVID-19 infections occurs before, during, or after participation in any hosted or programmed event by this organization.

Our mutual goal is to provide every reasonable step to slow the spread of the virus. Please sign that you have received, read, and understand this document, the 2020 – 2021 Family Handbook, and your child will attend St. Andrew Preschool with good health to the best of your knowledge.
